Minutes from the June 20, 2015 regular meeting of Council of the Resort Village of Mistusinne held at 9 a.m. in the Mistusinne Community Centre. The meeting was attended by Mayor Lynne Saas, Councillors Lloyd Montgomery, Joe Jozsa, Craig Peterson, Admin Assistant Leeanne Hurlburt, and Administrator Yvonne Jess.

Mayor Lynne Saas called the Council Meeting to order at 9:05 a.m.

- 55/2015 PETERSON: That the agenda be accepted as amended. Carried.
- 56/2015 JOZSA: That the minutes from the May 23, 2015 regular meeting be approved as presented. Carried.

Council held an open meeting regarding dandelions in the Resort Village, providing an opportunity for concerned ratepayers to attend the meeting and bring their concerns to council's attention.

The following ratepayers attended the meeting and were given an opportunity to take part in the discussion: William Pettigrew, Ken Arcand, David Achter, Betty Ann Erickson, Gary Quinney, Diane Quinney, Vina Walker, Carol Dorward, Bruce Dorward, Marlene McKay, Grant McIntyre, Lee McIntyre, Linda Reiss, Bernie Volk, Diana Humenick, Pat Carey, Patricia Carey, and David Cawood

Mayor Saas provided a review of Council's policy on mowing.

Councillor Jozsa introduced Richard Wilkins, Provincial Specialist Pesticide Regulatory, from the Ministry of Agriculture, who provided some information on pesticides, their application and various substructure conditions.

Mayor Saas read the email we received from Dr. Karen Bailey regarding safe dandelion control.

Mayor Saas provided information on the "scientific approach" to dealing with dandelions as laid out in our OCP; issues that other Resort Village's have faced in regards to a supply of good quality ground water, and information from the water labs that we haven't been testing our well water for the presence of pesticides (only bacteria and nitrates).

Councillor Jozsa referenced a US study that indicates that the presence of pesticides stay in the water for a long time. The Canadian Cancer Agency cautions against using chemicals.

Councillor Montgomery provided information from the Saskatchewan Urban Municipalities Association (SUMA) who suggested mow dandelions while they're still yellow; it's the only way to control them mechanically.

Councillor Peterson stressed that we all want to protect the groundwater and was encouraged with the idea of getting a consultant to help us out in this situation.

57/2015 SAAS: That we instruct Councillor Jozsa to develop the terms of reference, and search for a consulting firm to do some research for us in regards to chemicals and the potential effect on groundwater, and to also see if there is some help from research people to cut down on costs for such a study. Carried.

Mayor Saas reported on the invasive species presentation put on by the South Saskatchewan River Watershed Stewards in Elbow on June 17th. The SSRWS are taking over the initiative to rally people to patrol/watch for contaminated boats. They are setting up stations for sampling in Elbow and Danielson. They indicated that Lake Diefenbaker is the second highest 'at risk' lake in Saskatchewan.

58/2015 SAAS: That we put up a sign at the boat launch, send out a mail out on the dangers of aquatic invasive species. Carried.

Councillor Montgomery declared a conflict of interest in the following item.

- 59/2015 JOZSA: That we approve of the proposal presented by Carol Dorward, on behalf of some residents on Mistusinne Crescent, for a 'Welcome to Mistusinne Crescent' sign to be purchased and set up at their cost. Carried.
- 60/2015 PETERSON: That we issue a 'Temporary Residence During Construction' permit to Duane & Kathy Siemens while contractors are working on their cabin due to the fire May 6th, and that they are allowed to be on the greenspace behind their property until such time they are able to move their camper onto their property once the contractors are done. Carried.
- 61/2015 MONTGOMERY: That we hire someone with a bobcat to come and remove the sand from the boat launch. Carried.
- 62/2015 PETERSON: That we approve the Canada Day Committee requests for civic services for the annual Canada Day Celebration. Carried.
- 63/2015 MONTGOMERY: That we approve the Mistusinne Charity Golf Tournament Committee's requests in order to run the golf tournament on August 15th. Carried.

DELEGATION – 11:15 a.m. – Brian and Karen Summers attended the meeting to discuss their building plans.

- 65/2015 SAAS: That the Administrator make arangements for Admin Assistant Hurlburt to have a Global Payment Card through Prairie Centre Credit Union. Carrieed.
- 66/2015 PETERSON: That we renew our WaterWolf membership for 2015-16. Carried.
