Bylaw No. 04-2026

**A BYLAW TO REGULATE THE USE OF STORAGE SPOTS WITHIN
THE STORAGE YARD**

The Council of the Resort Village of Mistusinne in the Province of Saskatchewan enacts as follows:

1. Storage Spots costs are listed in the Fee Bylaw. Spots will not be pro-rated. When opting in, the cost is per spot per year, regardless of when the spot is secured. Spots run from May 1 to April 30 each year.
2. Fees will be invoiced by the last day of Feb every year. Invoices are due by the last day of March.
3. If a site is not renewed all items must be removed by the Thursday before May long weekend. No exceptions. Failure to comply, may result in removal of items at the occupant's expense. These fees will be added to the tax roll Dec 31, if not paid.
4. Occupants must supply the office with a phone number and email address. Contact must be updated with the office if changes occur throughout the year.
5. Storage spots do not transfer ownership. When a property is sold the new owners must contact the office to secure a spot, or to be added to the wait list if a spot is not available.
6. Occupants will be invoiced automatically the next year unless the office was advised by Dec 31 that the spot would be vacated.
7. A fee will be levied if occupants do not opt out of the program by Dec 31 annually as per the Fee Bylaw.
8. There is a map available from the office. The storage map advises where the Spot Number of the corresponding spot is located. Occupants must be certain that all items are located in the appropriate spot. The map is attached and forming part of this bylaw as [Schedule A].
9. The storage yard does not receive snow removal in the winter.
10. Some spots are better suited for long term storage, vs daily in and out use. Occupants should be certain that the assigned spot is appropriate for individual needs prior to occupying the spot. Storage spots are assigned in order of number availability.
11. The storage yard is to be used for seasonal recreational storage only.
12. Council has the authority to deem items not suitable for storage in the storage yard and request immediate removal.
13. Applicants may apply for a second spot, if spaces are available.
14. The Village assumes no liability for items stored in the storage yard.
15. Occupants must be property owners in the Resort Village of Mistusinne.
16. Residents are required to maintain their spots as per the regulations laid out in Bylaw 05-2005 the Nuisance Bylaw.
17. All lots are 30 Feet By 10 Feet.
18. This bylaw comes into effect April 19th, 2026.
