We are in the process of revamping the communication system. You should have received a test email Oct 3rd. If you did not or would like to add an additional address please contact the office.

Water:

The water will be turned off Oct 18th. All attachments to standpipes must be removed. The system is currently under going major upgrades and may be off and on as we get setup prior to the official off date!

Cabins tied into the Water System:

Please be advised that it is not permitted to tie your cabin into the water system. This is against regulations and can come with fines or dire consequences for the Municipality. In the upcoming season an inspection will be completed to ensure no one is connected. Please prepare accordingly.

Sewer:

Tanks will be measured after Thanksgiving. All tanks over 18" must be dumped at the home owners expense UNLESS you have completed

the opt out waiver form or registered as a permanent resident. Please contact the office prior to the opt out deadline of October 14.

Water Testing

40 people participated in the Water Testing pilot project this year. We will host again next year. The dates will be announced in the Spring Newsletter.

Storage Sites:

There are 12 sites still unpaid for. We have issued invoices please be sure that you have paid by October 14, 2022. If you have not paid by this date your spot will be reallocated to someone on the waitlist.

Campers on Green Space

Campers are allowed with an approved permit only, and for a maximum of 7 days at a time. In the spring there will be a tour conducted and all campers permanently placed on the Green Space will be towed at the owner's expense. Please relocate all units to your own property before the first snowfall.

Building Permits:

If you know that you will require a building permit for something in the spring please contact the office over the winter. If we complete all of the leg work in the slow season you will be in a position to build at your leisure come spring. Permits are valid for 1 year.
